Foals will need to be nominated EACH year to remain eligible. The 2021 stallion enrollment continues to qualify your 2017-2019 offspring for the jackpot classes at the 2021 futurity. **Note:** The 2021 ranch horse futurity will begin the first year of Stallion Enrollment payout classes, making only 2020 foals from 2019 enrolled stallions eligible AND are required to pay a nomination fee to be eligible to show in the 2021 yearling futurity classes.
