

WHEREAS, IQHA Ranch Horse Stallion Breeders Program & Futurity, the "Organizer", has the exclusive right to organize and conduct a Futurity which is to be held at the Iowa State Fairgrounds in Des Moines, Iowa on September 23rd-September 25th, 2022 and to be known as the IQHA Ranch Horse Stallion Breeders Futurity and

WHEREAS, Sponsor has determined to provide financial support for the Event in exchange for certain promotional rights to be provided by the Organizer;

NOW, THEREFORE, in consideration of the mutual agreements and promises contained herein, the parties hereto agree as follows:

1. ADVERTISING AND PROMOTION

- 2.1 Organizer grants to Sponsor the exclusive right during the term of this Agreement to use Organizer's Trademark or logo in advertising and promotional activities as it deems desirable during the term of this Agreement.
- 2.2 Sponsor will provide and grant the right to the Organizer to use Sponsor's logo or trademark in advertising and promotional activities during the term of this Agreement.
- 2.3 Organizer agrees to provide all advertising and promotional activities in accordance with the level of sponsorship provided.
- 2.4 Sponsor agrees that the Organizer has the right to sell or give away promotional merchandise that may be provided by the sponsor and/or contain the Sponsor name, trademark, or logo.

2. SPONSORSHIP FEE

In consideration of the full performance by Organizer of all its obligations hereunder and of all rights granted hereunder to Sponsor, Sponsor agrees to pay the total sum of the Sponsorship Fees no later than August, 31, 2022.

3. INDEMNITY

Each party will indemnify, defend, and hold harmless the other, its parent, subsidiary, and affiliated corporations, and their respective directors, officers, employees, agents, successors, and assigns, from and against any and all claims, damages, liabilities, losses, government proceedings, and costs and expenses, including reasonable attorney fees, and costs of suit, arising out of any alleged or actual breech of this Agreement or the inaccuracy of any warranty or representation made by it or any act or omission by it in the performance of this Agreement or the purpose hereof.

4. INSURANCE

Each party hereunder shall obtain and maintain at its own expense, during the term of this Agreement, a standard Comprehensive General Liability Policy, which shall (i) specifically cover such party's incidental contractual obligation, (ii) provide standard liability protection. Sponsors who will have booths at the event will be required to list Iowa Quarter Horse Association as an Additional Insured on their policy, as well as provide a Certificate of Insurance no later than August 31, 2022 to IQHA.

5. TERM AND TERMINATION

This Agreement shall become effective on the date of first above written and shall expire on September 26, 2022.

6. COMPLETE AGREEMENT

This Agreement represents the entire agreement between the parties and supersedes all other agreements, if any, expressed or implied, whether written or oral. Organizer has made and makes no representations of any kind except those specifically set forth herein.
