## Ranch Horse Futurity

\*IQHA membership is not required to enroll stallions; however, to nominate offspring and exhibit IQHA membership is required. New stallion nominator agrees to pay the enrollment fee of \$450 postmarked by or before May 1st or the late fee of \$500 from May 1 - July 1<sup>st</sup>. Returning stallion owners agree to pay the nomination fee they locked in at (\$350.00 or \$450.00 pending which deadline they entered by). The enrollment payment will permit resulting AQHA offspring eligibility for this futurity. It is not the responsibility of IQHA to contact mare owners of their right to nominate eligible offspring.
